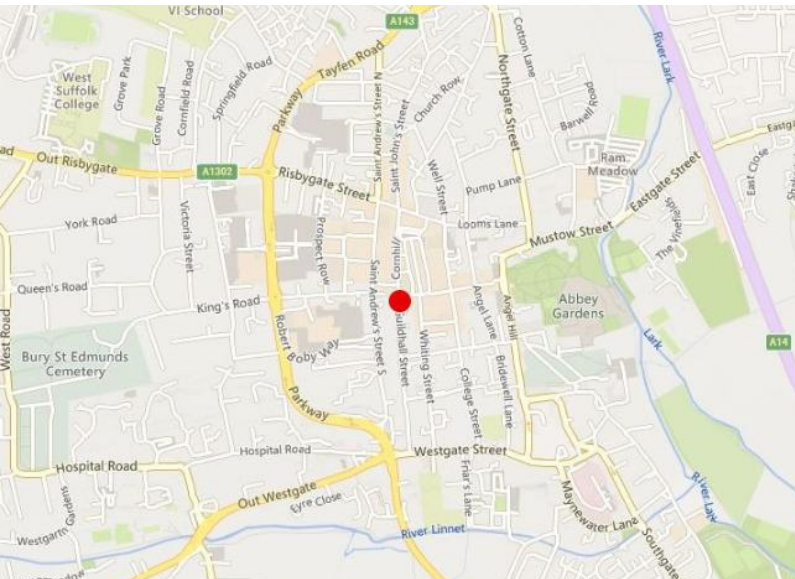
The ground floor sales area is open plan and the first floor provides a WC, kitchen area and two offices/stores.
